for the quarter ended 12/31/17**

- 1). Total NAU account balance at 12/31/17, including operating account, reserve account, customer deposits, connection fees, and net of reimbursements due, was \$ 8,786,039.61
- 2). BOCC investment funds include \$2,418,949.09 in an agency fund related to the financing of the SAISSA beach renourishment project.
- 3). The SAISSA CD matured 9/25/17, however; there was a grace period from when the CD matured and the money was transferred on 10/4/17.
